



VISITING GUIDELINES & WAIVER FORM

👉 VISITS BY APPOINTMENT ONLY 👈

Please follow these guidelines for your safety and enjoyment, and to protect the well-being of our animals.

- Please do not feed the animals or bring treats, as they are well fed on specialized, high nutrient diets.
- Wear suitable shoes or boots that you don't mind soiling.
- Aim for neutral-colored clothing over bright colors.
- If you have allergies (e.g., hay or pollen) or mobility issues, bring necessary medications or mobility aids.
- Speak softly and do not make sudden movements that could excite the animals.
- Be mindful entering and exiting enclosures that separate animals for their protection—always re-latch and double latch gates.
- Minimize or avoid taking photos and videos. Enjoy your time bonding with nature, without distraction or compromising your safety.
- Keep pets at home to prevent disease transmission or distress.
